We, the undersigned, do hereby associate ourselves together and subscribe The Articles of Incorporation for the purpose of forming corporation under the Laws of the State of Florida, Chapter 607 and subject to the following provisions:

### ARTICLE ONE

The name of the Corporation shall be:

SISTEMAS BOLIO, inc.

### ARTICLE TWO

This corporation shall have perpetual existence and may engage in any Activity or business permitted under the laws of the United States of Florida

The general nature of business to be transacted by this corporation shall Be:

a) This Corporation is organized for the purpose of engaging in a business Organized under Florida General Corporation law, Chapter 607, Florida States.

b) To manufacture, purchase or otherwise acquire, and to own mortgage, Pledge, sell, assign, transfer or otherwise dispose of, and it invest in, trade in, and deal in and with, goods, wares, merchandise real and personal property, and services of every class, kind and description.

### ARTICLE FOUR

The rights accruing to any person under the foregoing provisions shall not exclude any other right to which he or she may be lawfully entitled nor shall Anything contained restrict the right of the corporation to indemnify of reimburse Such person in any proper came even though not specifically herein provided for

No contract or other transaction between this corporation and any other Corporation and no act of this corporation shall in any way be affected or invalidated by the fact that any of the directors of the corporation are pecuniary or Otherwise interested in, or are directors, or officers, of such other corporation. Any Director individual or any firm of which any director may be a member, may be a Party to, or may be pecuniary or otherwise interested in any contract or transaction Of the corporation, provided the fact that his interest should be disclosed or should have been known to the Board of Directors or such members thereof as shall be Present at any meeting of the Board of Directors at whish action upon any such Contract or transaction shall be taken, and any director of the corporation who is so Interested may be consted in determining the existence of a quorum at any meeting Of the Board of Directors of the Corporation which shall authorize any such Contract or transaction with the like force and effect as if he were no such director Or officer of such other corporation or not so interested.
