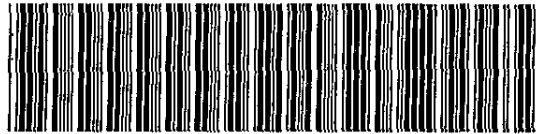

**ARTICLES OF INCORPORATION OF
PAMPERED TIPS & TOES NAIL SALON, INC.**

ARTICLE I

The name of the corporation is **PAMPERED TIPS & TOES NAIL SALON, INC.**, having its principal office located at: 3901 North Park Road, Hollywood, Florida 33021.



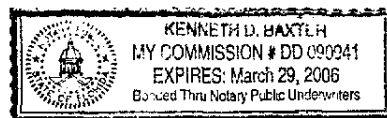
