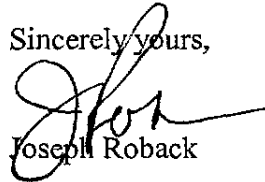

The corporation is being formed, and these Articles are being subscribed to by MARK D. RAIBLE, whose address is 212 77th St. W., Bradenton, FL 34209.

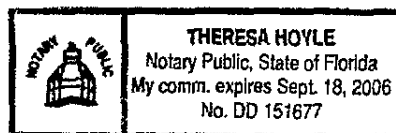
