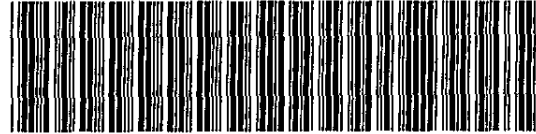

Article I


