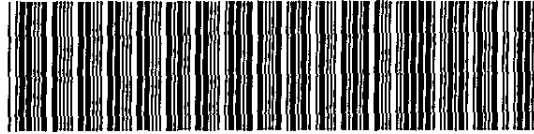

### **INDEMNIFICATION**






