The undersigned incorporator of theses Articles of Incorporation does hereby form a corporation pursuant to the Florida General Corporations Act and does hereby adopt the following Articles of Incorporation:

ARTICLE ONE NAME AND PRINCIPAL OFFICE

The name of this corporation is G & A AUTOBODY, INC. The corporation's principal office is located at 15036 U.S. # 19 N, Hudson FL 34667.

ARTICLE TWO DURATION

The corporation is to exist perpetually.

ARTICLE THREE PURPOSE

This corporation is organized to transact any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act, including auto body repairs.

ARTICLE FOUR CAPITAL STOCK
