The undersigned, acting as Incorporator of a corporation in compliance with Chapter 621, F.S. (Profit), adopt the following articles of incorporation for such Corporation:

ARTICLE ONE

NAME OF CORPORATION

The name of the corporation, hereinafter referred to as the "Corporation," is
CONSTRUCTION MANAGEMENT OF DELTONA, INC.

ARTICLE TWO

CORPORATE DURATION

The period of duration of this Corporation is perpetual.

ARTICLE THREE

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. The general nature of the business, objectives and purposes to be transacted by this corporation, promotion and realization as a for profit corporation, are all those and any of those herein mentioned. The corporation may engage in any activity or business as broad as the term can be interpreted and which can be developed by a natural person.

5. Merge, consolidated or enter into any type of agreement with other persons, Organizations or corporation.

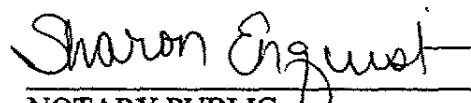

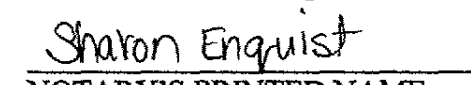
