ARTICLES OF INCORPORATION

OF

SWORCOTTAGE STABLES, INC.

The undersigned incorporators hereby associate themselves together to form a corporation under Chapter 607, Florida Statutes.

ARTICLE I
NAME & PRINCIPAL PLACE OF BUSINESS

The name of the corporation is SWORCOTTAGE STABLES, INC., and its principal place of business is 15050 S.E. 140TH Avenue Road, Weirsdale, FL 32195, with a mailing address which is the same.

ARTICLE II
GENERAL PURPOSE


The power to adopt, amend or repeal the Bylaws shall be reserved to the shareholders of this corporation.

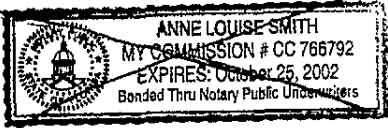


