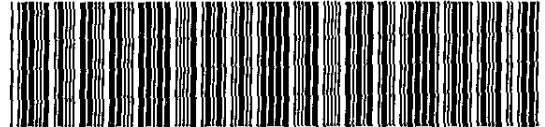

ARTICLES OF INCORPORATION
OF
ACCUCHEK HOME INSPECTIONS, INC.

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be Accuchek Home Inspections, Inc.

ARTICLE II – PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 25835 Shawnee St., Sorrento, FL 32776, which shall also be the mailing address of the Corporation.

ARTICLE III – CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is one thousand (1,000) shares of common stock having a par value of ten cents (\$0.10) per share.

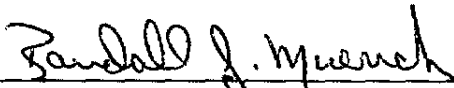
ARTICLE VIII – DATE OF EXISTENCE
