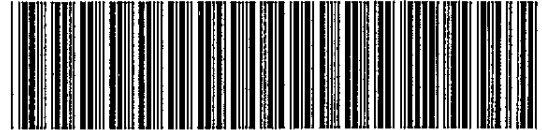

**ARTICLES OF INCORPORATION
FOR
STILLINGS, INC.**

For the purpose of forming a corporation under Florida law, the incorporator hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is STILLINGS, INC.

ARTICLE II. DURATION

The duration of this corporation shall be perpetual.

ARTICLE III. PURPOSE

The purpose of this corporation shall be cable installation training and special event coordination, and any other lawful business for which a corporation may be incorporated under the Florida General Corporation Act.
