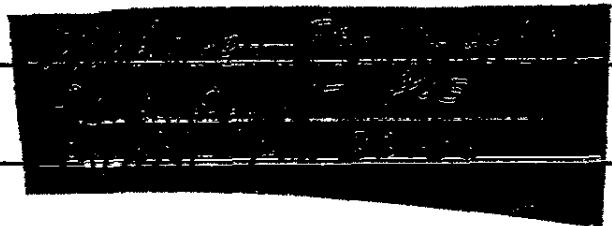

ARTICLES OF INCORPORATION
OF
DOLLAR PLUS INC

THE UNDERSIGNED, has executed the following document as incorporators of the above named corporation, a corporation organized under the laws of the State of Florida, and all rights, duties and obligations of the undersigned as incorporator, and Those of the corporation, are to be determined in accordance with the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

DOLLAR PLUS INC

ARTICLE II

This corporation shall commence existence upon the filing of these articles of incorporation by the Department of State, State of Florida, and shall have perpetual existence.

ARTICLE III

The general nature of the business and objects and purposes proposed to be transacted and carried on by this corporation are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might do, viz

(1) Transact any and all lawful business.

(2) Said corporation shall further have powers:

To purchase, take, receive, lease, otherwise acquire, own, hold, improve, use, and deal in and with real or personal property or any interest therein, wherever situated;

To Sell, convey, mortgage, pledge, create a security in, lease, exchange, transfer, and otherwise dispose of all or any of its property assets;

To lend money to, and use its credit to assist, its officers and employees in Accordance with Florida Statute S 607;

To purchase, take, receive, subscribe for or otherwise acquire, own, hold, vote, use, employ sell, mortgage, lend, pledge, or otherwise dispose of and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the united states or of any other government, state, territory, government district, or municipality or of any instrumentality thereof;

To make contracts and guarantees and incur liabilities, borrow money at such rates of interests as the corporation may determine, issue its notes, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises and income;

To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security of the payment of funds so loaned or reinvested;

To pay attention and establish pension plans, profit sharing plans, stock Bonus plan Stock option plan, and other incentive plans for any or all of its directors, officers, and employees of its subsidiaries;

To be a promoter, incorporator, partner, member, associate, or manager of any corporation, partnership, joint venture, trust, or other enterprise;

To have and exercise all powers necessary or convenient to effect its purposes;

To indemnify any person who by reason of the fact that he is or was a director, officer, employee or agent of the corporation to the full extent as permitted by Florida Statute S 607.014;
