ARTICLES OF INCORPORATION

OF

We, the undersigned, desiring to organize a corporation for the purposes hereinafter stated, pursuant to the laws of the State of Florida, hereby certify as follows:

ARTICLE I - NAME

The name of this corporation shall be:

ARTICLE XIV - PREEMPTIVE RIGHTS


