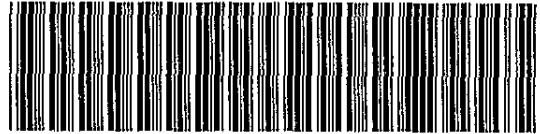

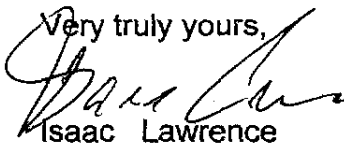

ARTICLE I

The name of this corporation is 5 STARS BODY SHOP, INC. Whose principal address is 5829 Funston Street Hollywood, Florida 33023.

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in Auto Body Repair, a business permitted under the laws of the State of Florida.

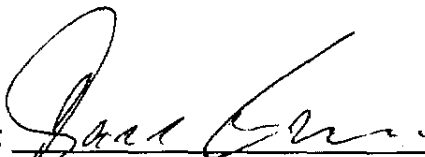

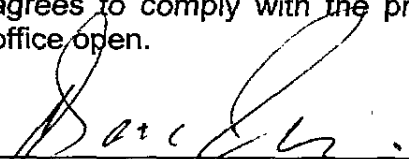
