### ARTICLES OF INCORPORATION

### <u>OF</u>

### RUTH E. LAWLER, P.A.

- 1. NAME. The name of this corporation is RUTH E. LAWLER, P.A.
- 2. PURPOSE. The purpose for which the corporation is organized is to render real estate brokerage services through its officers, employees and agents who are duly licensed or otherwise authorized to render such services within the State of Florida. The term "employee" as used herein shall mean the same as the term "employee" under Fla. Statutes §621.06 (2003), as amended.
- 3. CAPITAL STOCK. The aggregate number of shares of stock which the corporation shall have authority to issue is 1000 and each share shall be of the par value of \$1.00.
- 4. DURATION. The corporation shall have perpetual existence, and its existence shall commence on the date of the execution and acknowledgment of these Articles of Incorporation.
- 5. INITIAL REGISTERED OFFICE AND AGENT. The street address of the initial registered office of the corporation is 425 19th Street Court West, Bradenton, FL 34205, and the name of the initial registered agent of the corporation at that address is Ruth E. Lawler. The principal business address of the corporation is 425 19th Street Court West, Bradenton, FL 34205.
- 6. NUMBER OF DIRECTORS. The corporation shall have one director initially.
  The number of directors may be increased or diminished from time to time, by by-laws by the stockholders, but shall never be less than one.
