#### ARTICLES OF INCORPORATION

#### OF 3P INVESTMENTS, INC.

The undersigned incorporator hereby certifies to the following in order to form a corporation for a profit under the laws of the State of Florida.

#### **ARTICLE I - NAME**

The name of this corporation is, 3P INVESTMENTS, INC.

#### **ARTICLE II - DURATION**

This corporation shall have perpetual existence.
