# ARTICLES OF INCORPORATION OF

### Ever Pena Pressure Cleaning, Inc.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the state of Florida.

#### ARTICLE I- NAME

The name of this corporation is Ever Pena Pressure Cleaning, Inc.
