## ARTICLE OF INCORPORATION OF PANETO CONSTRUCTION, INC.

#### **ARTICLE 1- NAME**

The Name of the Corporation is **PANETO CONSTRUCTION, INC.** (hereinafter, "Corporation").

#### **ARTICLE 2- PURPOSE OF CORPORATION**

- 7.4 The Board of Director(s) of the Corporation may, by Restated Articles of Incorporation, classify or reclassify any unissued stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of the stock.

#### ARTICLE 8- POWERS OF CORPORATION
