The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation: associate

ARTICLE I: NAME

The name of the Corporation is ROTOAIRA FARMS, Inc. Principal place of business is 150 S. University Drive Suite F, Plantation, FL 33324.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.
