ARTICLE I – NAME

The name of this corporation is: Line Um' Up Entertainment Inc.

ARTICLE II – DURATION

This Corporation shall have perpetual existence commencing on the date of execution and acknowledgement of these Articles.

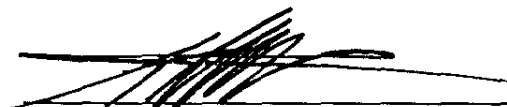

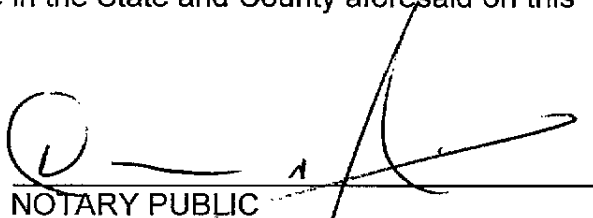
