

ARTICLES OF INCORPORATION OF
RAINES CARPENTRY & PAINTING, INC.

KNOW ALL MEN BY THESE PRESENTS, that the undersigned ^{STATE OF FLORIDA} has come this day for the purpose of forming a corporation under the laws of the State of Florida, and to that end does hereby adopt Articles of Incorporation, as follows:

ARTICLE I

The name of the proposed corporation is:

RAINES CARPENTRY & PAINTING, INC.

ARTICLE II

The general nature of the business to be transacted by the Corporation shall be carpentry & painting as well as commerce of any and all types.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ten (10) shares at no par value each. Authorized capital stock may be paid for in cash, or in services or property, in which case, just value shall be fixed by the Board of Directors of this Corporation at any regular or special meeting.

ARTICLE IV

The classification of shares of stock shall be as follows:

Common - 10 shares - no par value

ARTICLE V

The amount of capital with which the Corporation will begin business is Two Thousand Dollars (\$ 2000.00).

ARTICLE VI

The corporation shall have perpetual existence.

ARTICLE VII

Principal office

The street address of the corporation's principal office is 87 Hidden Valley Trail, Havana, Fl 32333.

Registered agent

The name of its initial registered agent is Larry S. Wolfe, Sr. and the address of the registered agent is 200-A John Knox Road, Tallahassee, Florida 32303.

ARTICLE VIII

The number of directors of the Corporation shall be as provided in the By-Laws, but shall not be less than one (1) in number, nor more than five (5), and shall be one (1) in number until otherwise fixed or changed by the By-Laws.

ARTICLE IX

The name and post office address of the first Board of Directors, who, subject to the provisions of the Articles of Incorporation, the By-Laws of this Corporation, and the laws of Florida, shall hold office for the first year of the corporation's existence, or their successors are elected and qualified is as follows:


