## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MARLON D. LYNN, P.A.

Pursuant to the provisions of Chapters 621 and 607, Florida Statutes, MARLON D. LYNN, P.A. (the "Corporation") has adopted the following Amendment to its Articles of Incorporation:

1. Article VII is hereby deleted and replaced with the following:

### ARTICLE VII - BOARD OF DIRECTORS

This corporation shall have one (1) director. The number of directors either may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than (1). No one other than an individual who is duly licensed as an architect under the laws of the State of Florida shall be eligible to serve as a director of this corporation unless the ownership of shares of stock in this corporation shall be transferred into the hands of a person or person who is or are not qualified to own such shares under the provisions of Chapter 621, Florida Statutes, in which case the provisions of Article XIV shall apply.

The number of officers and offices either may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than (1). No one other than an individual who is duly licensed as an architect under the laws of the State of Florida shall be eligible to serve as an officer of this corporation unless the ownership of shares of stock in this corporation shall be transferred into the hands of a person or person who is or are not qualified to own such shares under the provisions of Chapter 621, Florida Statutes, in which case the provisions of Article XIV shall apply.
