

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I - Name

The name of this Corporation is MCCOY HOME INSPECTIONS, INC. The principal place of business of this Corporation shall be 5127 Log Cabin Drive, Lakeland, Florida 33810 or such other place as may be designated by the Board of Directors.
