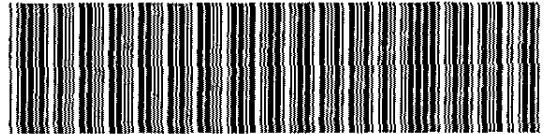

The number of Directors constituted in the initial board shall be two (2). The names and addresses of the Directors serving on the board are as follows:


