ARTICLES OF INCORPORATION OF RTT CONSULTING, INC.

The undersigned subscriber, a natural person competent to contract, here by associate together to form a corporation under the Laws of the State of Florida, Chapter 607, and subject to the following provisions:



ARTICLE I - NAME

The name of the corporation shall be: RTT CONSULTING, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of the Articles of Incorporation, or the date of execution and acknowledgement of these Articles.

ARTICLE III – PURPOSE

This corporation is organized for the [purpose of transacting any or all lawful business, including but not limited to:

- a. Any and all lawful business.
- Pursue its purposes and business in any and all locations foreign and domestic.
- c. Acquire, own, hold, develop, deal in and with, maintain and operate, unlimitedly, such real and personal property of every kind and description within and without the State of Florida.

- Engage in the acquisition, ownership, sale, and distribution and licensing of
 patents, improvements and franchises, trademarks and trade names, and to
 operate they're under.
- k. Enter into, make and perform contracts of every kind and description with any person, firm or association, corporation and body politic conducive to the attainment of any of the objects or purposes of the corporation.
- Enter into any and all types of agreements relating to financing, factoring and guarantees and to guarantee or secure, in any way, the debts or obligations of any other persons, firms and/or corporations.
