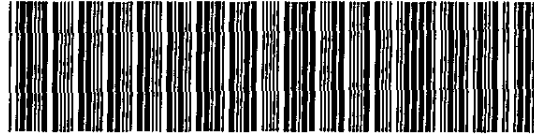



**ARTICLE I


