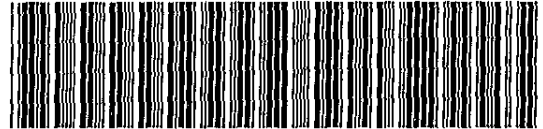

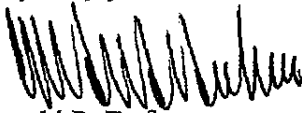

ARTICLE I- NAME AND ADDRESS

The name of this corporation is TRIO JET SERVICES, INC. with its principal address at 11839 Pebblewood Drive, Unit 7023, Wellington, Florida 33414.

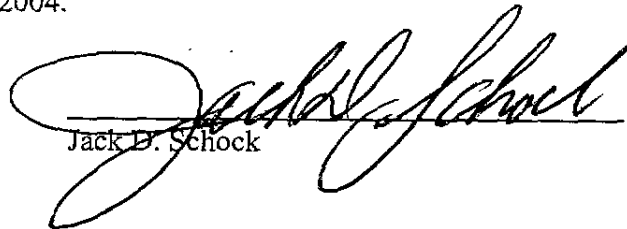
