ARTICLES OF INCORPORATION OF TAMPA BAYS CONNECTION INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME. The name of this corporation is **TAMPA BAYS CONNECTION**INC.


