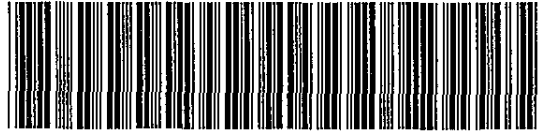

NAME

The name of this corporation is H & G Advisors, Inc.

AMENDMENT

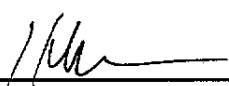
