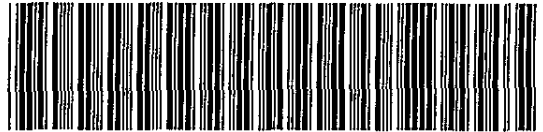

**ARTICLES OF INCORPORATION OF
EXTREME MARTIAL ARTS ACADEMY, INC.**

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE I – NAME AND PRINCIPAL OFFICE

The name of the corporation is Extreme Martial Arts Academy, Inc. The principal place of business and mailing address of the corporation is 14450 SW 138th Court – Miami, Florida 33186.

ARTICLE II - SHARES

The corporation shall have the authority to issue 10,000 shares of stock. Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share.
