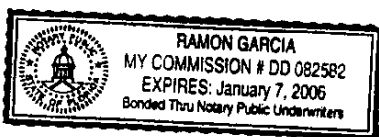
1. Rafael Navarro is the President of TRUCKTRONICS, INC., a Florida corporation, (hereinafter "Corporation").
