Initial Board of Directors

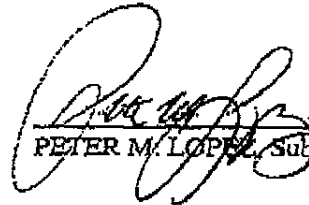
