ARTICLES OF INCORPORATION
OF
ANDERSON BUILDING COMPANY, INC.

ARTICLE I. NAME

The name of the corporation is ANDERSON BUILDING COMPANY, INC.

ARTICLE II. DURATION

The corporation shall commence upon the execution of these Articles and shall exist perpetually.

ARTICLE III. PRINCIPAL OFFICE

ARTICLE IV. PURPOSE
