The undersigned subscribers to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is: TNT OF MARCO, INC., a new Florida Corporation. The mailing and business address is 969 N. Collier Blvd., Marco Island, FL 34145.

ARTICLE II

The general nature of the business is restaurant consultant.

ARTICLE III
