## ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, and natural person competent to contract, hereby organizes and incorporates a corporation under the laws of the State of Florida.

#### ARTICLE I. NAME

The name of the corporation is: PAK AUTOTRADE INTERNATIONAL, CORP.

#### ARTICLE II. NATURE OF BUSINESS
