ARTICLES OF INCORPORATION OF NEUROMUSCULOSKELETAL IMAGING ASSOCIATES, P.A.

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a professional service corporation (the "Corporation") under the Florida Professional Service Corporation Act (the "Act"), as follows:

ı. <u>Name</u>

The name of the Corporation is Neuromusculoskeletal Imaging Associates, P.A.

II. <u>Term of Existence</u>

The Corporation's existence commences on the date of the filing of these Articles of Incorporation with the Department of State of the State of Florida. The Corporation will have perpetual existence thereafter.

III. Principal Office

IV. Nature of Business and Purposes

V. Capital Stock

The Corporation is authorized to issue 7,500 shares of \$1.00 par value common stock, which will be designated Common Stock.

VI. Stockholders

The Corporation's Common Stock will be issued only to an individual who is duly licensed as a doctor of medicine under the laws of the State of Florida. No shareholder of the Corporation may sell or transfer his or her shares of Common Stock except to another individual who is duly licensed to practice medicine under the laws of the State of Florida. No shareholder of the Corporation will enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his or her shares of the Corporation's Common Stock.

VII. Directors

The Corporation will have 3 directors initially. The number of directors may be increased or decreased from time to time as provided in the bylaws of the Corporation, provided that the Corporation will always have at least 1 director.
