

CERTIFICATE OF INCORPORATION **KUTY & ASSOCIATES, INC.**

We, the undersigned, in order to form a Corporation for profit for the purpose hereinafter state, under the pursuant to the provision of the Florida Statutes, do hereby subscribed to this certificate of Incorporation, and do adopt the following Articles of Incorporation:

ARTICLES OF INCORPORATION

ARTICLE I

The name of Corporation shall be: KUTY & ASSOCIATES, INC.

ARTICLE II

The term for which this corporation shall exist, shall be perpetual, the principal place of business and the mailing address of this corporation shall be: 5110 Kathy Lane C West Palm Beach, Florida 33415.

ARTICLE III PORPOSE OF CORPORATION

The general nature of the business and the objects and purposes to be transacted and carried on by this corporation shall be:
