

Articles of Incorporation Of GRAMMAN'S GOOD NATURE, INC.

The undersigned, acting as incorporators of a corporation (hereinafter referred to as the "corporation") under provisions of the Florida Business Corporation Act, as amended from time to time, adopt the following Articles of Incorporation:

ARTICLE I. The name of the corporation is GRAMMAN'S GOOD NATURE, INC.

ARTICLE II. The initial post office address of the principal office of this corporation in the State of Florida is: 9959 CR 114A, Wildwood, Florida 34785 The street address of the corporation is 9959 CR 114A, Wildwood, Florida 34785.

ARTICLE III. The general purposes for which this corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
