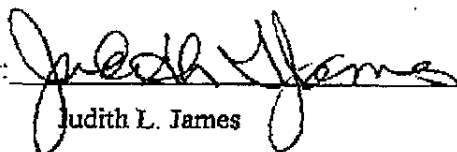
**ARTICLE X**

**PREEMPTIVE RIGHTS**

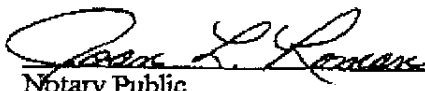

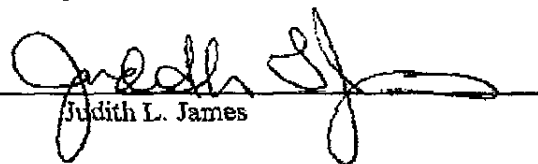

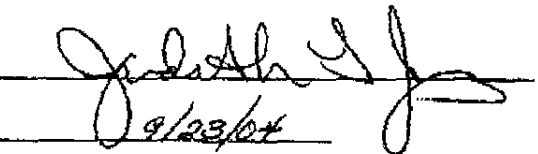
