ARTICLES OF INCORPORATION

FIRST: I, Gayatri Bahadur, whose post office address is 143 Lincoln Road, Lake Placid, Florida 33852, being at least eighteen (18) years of age, hereby form a corporation under and by virtue of the General Laws of the State of Florida.

SECOND: The name of the corporation (which is hereafter referred to as the "Corporation") is **GAYATRI DRAPERY & UPHOLSTERY, INC.**

THIRD: The principal place of business of the corporation is 105 Commerce Street, Lake Placid, FL 33852.

FOURTH: The purposes for which the Corporation is formed are as follows:
