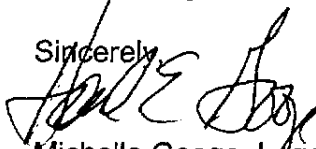

ARTICLE I - NAME

The name of this corporation is Wholesale Envelopes, Inc. and the principal place of business/mailling address is 896 SW Woodcreek Drive, Palm City, Florida 34990.

ARTICLE II - DURATION

This corporation shall exist in perpetuity commencing on the date set forth in Article XIII of these Articles.

ARTICLE III - PURPOSE
