Third: Article VII of the original Articles of Incorporation is further amended to reflect that the following person is now the sole officer and director of the Corporation:



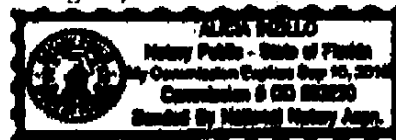
