# ARTICLES OF INCORPORATION OF

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation accordance with the laws of the State of Florida:

#### ARTICLE I - NAME

#### ARTICLE II - PURPOSE AND DURATION

The corporation shall have one Director initially. The number of directors may be thereafter increased or decreased from time to time, in accordance with the Bylaws of the corporation.
