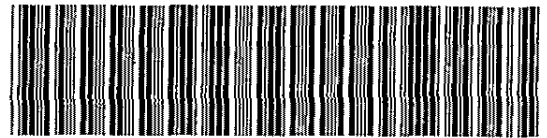

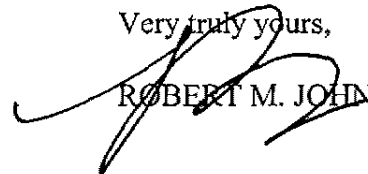

## **ARTICLES OF INCORPORATION**

**OF**

**BRUCE TASSINARE, P.A.**

In compliance with the requirements of forming a Corporation under the Florida Corporation Act, F.S. Chapter 607, as a Professional Service Company under the Professional Service Corporations Act, F.S. Chapter 621, the undersigned, being a natural person, hereby acts as the incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

### **ARTICLE I - NAME**

### **ARTICLE II - DURATION**

This Corporation is organized under F.S. Chapter 607 and F.S. Chapter 621. The Corporation's existence shall be perpetual, unless the Corporation is earlier dissolved as provided in these Articles of Organization.

Any action required or permitted by the Florida Corporation Act at an annual or special meeting of Stockholders may be taken without a meeting, without prior written notice and without a vote if consented to in writing by the holders of outstanding shares having at least the minimum number of votes necessary to authorize or ratify such action if taken at a meeting at which all shares entitled to vote were present and voted. Prompt written notice of the taking of said action shall be given to the nonconsenting Stockholders by (among other methods) mailing said notice to said Stockholders by first class mail, postage prepaid, to their address of record.

## **ARTICLE IX - COMMENCEMENT OF EXISTENCE**

The corporation shall be deemed to commence its existence on the first day the Corporation is qualified by law to transact business in the State of Florida.

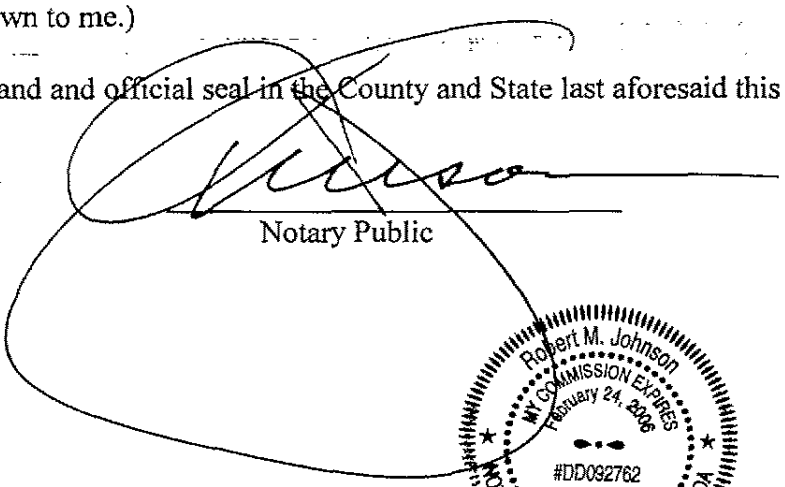

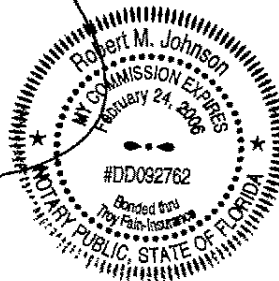
