ARTICLES OF INCORPORATION

OF

BOWDOIN CONSTRUCTION, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is Bowdoin Construction, Inc.

ARTICLE TWO

The duration of the corporation is perpetual.


