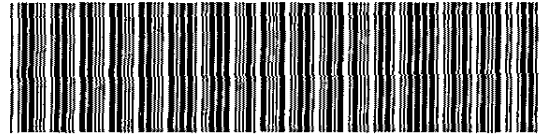

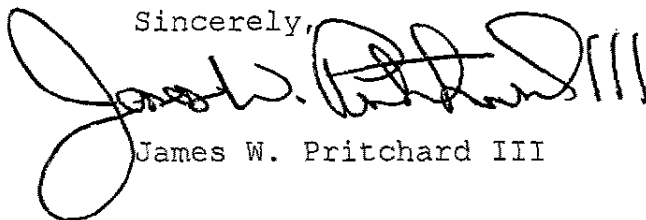

ARTICLE I - NAME

The name of this Corporation is Dauphins Handyman Service, Inc.

ARTICLE II - PRINCIPAL OFFICE AND

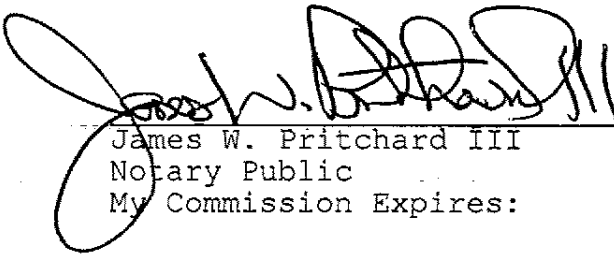
