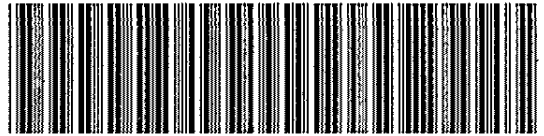

The undersigned, acting as the incorporator of the corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME: The name of the corporation is O H I ~~INC.~~ *Home Services, Inc.*

ARTICLE II

REGISTERED OFFICE AND REGISTERED AGENT: The street address and telephone number of the initial registered office is 101 MARSH ISLAND CIRCLE, ST. AUGUSTINE, FLORIDA 32095 (904)826-1347.

The name of the initial registered agent is MATTHEW C. STONE, who is familiar with and accepts of the duties and responsibilities as Registered Agent for said Corporation.

PRINCIPAL OFFICE AND ADDRESS is the same as the REGISTERED OFFICE.

ARTICLE VI


