ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: Domestic Distinctions, Inc. The principal office of the Corporation is 520 Sabal Lake Drive #210, Longwood, Florida 32779. The mailing address of the Corporation is 520 Sabal Lake Drive #210, Longwood, Florida 32779.

Article 2. Duration. The duration of the Corporation is perpetual.
