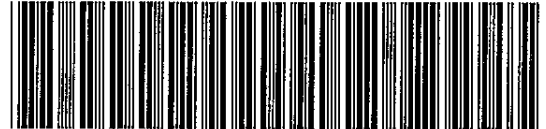

**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is CHANEY BRANCH FARM, INC.

This corporation shall exist perpetually.
