OF

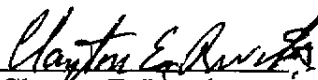
ARTICLE X. EFFECTIVE DATE

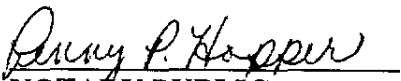
