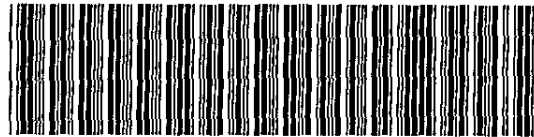

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.


ARTICLE X = INDEMNIFICATION

ARTICLE XI = AMENDMENT


The corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, and any right conferred upon the shareholders is subject to this reservation.
